The goal for AFF

To provide independent analysis and advice to national, regional and international institutions and actors, on how economic, food security and environmental issues can be addressed through the sustainable management of forests and trees

How AFF achieves its goal

- I. Networking: Networking among the many and varied stakeholders in forestry in Africa.
- 2. Programmes: Development of specific programs, projects and activities that address priority issues and opportunities and facilitate their funding.
- 3. Advocacy and policy advice: Advocacy activities that have a potential to raise the profile of forestry, highlight threats to forest resources and the environment, and champion better management of African forests.

People of all gender (men, women, youth) capacitated to contain loss of forest cover, expand the same, and sustainably use forests and tree resources

Value addition to African forest products

What we are looking for

Entrepreneurship opportunities and technologically efficient means for value addition to forest and tree products

What we would like to see happen

Well informed actors effectively engaged in forest and selected agricultural crop-based value chains, especially private sector, men, women and the youth, for improved wellbeing.

Currently working on gums and resins and other NTFPs, liquid biofuels and charcoal.

What we are looking for

Best practices that integrate both adaptation and mitigation options in response to the impacts of climate change and variability to biophysical and social systems in different landscapes

What we would like to see happen

Well informed African forestry stakeholders exploring synergies between global, regional and national climate change policies and initiatives in ways that better integrate their approaches to adaptation and mitigation to climate change challenges and opportunities into their different forest and tree resources and social systems.

Well informed African forest stakeholders about multilateral environmental processes and agreements, including those on NDCs, REDD+, IAF and SDGs; effectively (a) negotiating and articulating their forestry related interests in relevant discourses and

(b) implementing recommendations and decisions from the MEAs.
